 - Disturbance caused or created by Member/Guests.
 - Willful abuse to the club facility, staff, employees or premises.
 - Any other acts deemed inappropriate by management that may be detrimental to the club or other members.
6. No outside food or drink is permitted in Blend.
7. Pets, unless approved in advance, are not permitted in Blend.
8. Smoking is not permitted indoors.
9. VIP Members do not have to wait in line, and can escort 2 Guests to the front of the line for expedited admission.
